Data protection - report on the General Data Protection Regulation

As requested by Article 97 of the GDPR, the Commission will report on the application of this Regulation two years after its entry into application. The report will take into account the contribution from the Council, the European Parliament, the European Data Protection Board and those received from the GDPR Multi-Stakeholder Group (business and civil society representatives).

Statement by the EDPB Chair on the processing of personal data in the context of the COVID-19 outbreak

Governments, public and private organisations throughout Europe are taking measures to contain and mitigate COVID-19. This can involve the processing of different types of personal data.

Andrea Jelinek, Chair of the European Data Protection Board (EDPB), said: "Data protection rules (such as GDPR) do not hinder measures taken in the fight against the coronavirus pandemic. However, I would like to underline that, even in these exceptional times, the data controller must ensure the protection of the personal data of the data subjects. Therefore, a number of considerations should be taken into account to guarantee the lawful processing of personal data."

Cabinet adopts patient data protection law

Bringing digital solutions to the patient quickly and protecting sensitive health data in the best possible way - that is the aim of the draft of a "patient data protection law". The federal cabinet approved the draft today. With a new, secure app, insured persons can redeem eprescriptions in a pharmacy of their choice. Specialist transfers can be transmitted digitally in the future. And patients have the right to have the doctor fill their electronic patient record (ePA). From 2022, the vaccination card, the mother's passport, the yellow U-booklet for children and the tooth bonus booklet can also be saved there.

Washington, D.C. Amends Data Breach Notification Law, Adds Data Security Requirements

On March 26, 2020, Washington D.C. enacted bill number B23-0215, amending D.C.'s data breach notification law (the "Bill"). Among other requirements, the Bill requires the provision of identity theft prevention services in certain data breaches, establishes new regulatory reporting requirement in the event of a cognizable data breach affecting 50 or more residents of D.C., and imposes certain data security requirements on covered businesses.
